# **Supplier Code of Conduct**

# 1. 可持续性原则

可持续性和环保意识是汉格斯特价值观和企业文 化的核心要素。汉格斯特也希望其供应商具有这 种基本的企业态度和由此产生的行为。

汉格斯特提倡供应链的可持续发展。因此,以下可持续发展原则是对我们的供应商("**供应商**")的要求。遵守这些原则是与 Hengst SE 及其关联公司建立业务关系的重要基础,符合 § 15 ff. AktG (**"汉格斯特**"或 "**我们**")业务关系的重要基础。

## 1. Sustainable principles

Sustainability and environmental awareness are at the core of Hengst corporate values and culture. This corporate attitude and conduct are also expected from the Suppliers of Hengst.

Hengst promotes sustainable development throughout its supply chain. Therefore, the following sustainable principles are requirements for our Suppliers ("Supplier"). Compliance with these principles is the essential basis for a business relationship with Hengst SE and its affiliated companies according to sec. 15 et seq. AktG [German Stock Corporation Act] ("Hengst" or "we" or "us").

## 2. Human rights and labor standards

The Supplier is required,

 to not tolerate any discrimination based on age, gender, skin color, ethnic or social origin, nation-

- 防止任何形式的童工现象,并根据国际劳工组织(IL0)的标准,遵守有关雇员最低年龄的规定。
- 确保适当的工资、社会福利和工作时间,至 少符合供应商注册地点和工作地点的现行法 律规定。

- ality, national origin, health status, disability, sexual orientation, views or political attitudes, and any others defined by the laws in countries and locations where the Supplier operates.
- to endeavor to maintain equal opportunities among employees, while promoting them on the merit of qualifications and skills.
- to promote diversity, equal opportunities and inclusion.
- to pay attention to and respect internationally recognized human rights and to commit to compliance with these rights.
- not to do anything or refrain from doing anything in breach of duty that is directly capable of impairing a protected legal position (ILO Conventions No. 29, 87, 98, 100, 105, 111, 138, 182; International Covenant on Civil and Political Rights and on Economic, Social and Cultural Rights of December 19, 1966; Minamata Convention; Stockholm/POPs Convention; Basel Convention) in a particularly serious manner and the unlawfulness of which is obvious on a reasonable assessment of all the circumstances in consideration.
- to protect the rights of minorities and indigenous peoples.
- not to participate in land theft and to observe the ban on the unlawful eviction from land, forests, and waters when acquiring, building on, or otherwise using land, forests, and waters that serve as a person's livelihood.
- not to use forced or compulsory work or any form of slavery or practices similar to slavery, servitude or any other form of domination or oppression in the workplace in any form.
- to prevent abuse of power by contracted private or public security forces through proper selection, training and control.
- to explicitly condemn and prevent any physical punishment, threats or intimidation of employees.
- to explicitly prevent any form of child labor and to respect the regulations for minimum working age in accordance with the labor standards of the International Labor Organization (ILO).
- to ensure that wages, social benefits as well as working hours are appropriate and at least comply with the relevant statutory regulations in force at the Supplier's registered office and at the place of work.

- 3. 出口管制和经济制裁

供应商有义务

- 遵守与以下方面有关的经济制裁和进出口法律

- to respect the individual's right to freedom of association, participation in collective bargaining, and membership of labor unions.
- to protect employees against risks at the workplace, in particular to comply at least with the national occupational health and safety regulations applicable at the Supplier's registered office and at the place of work.
- to reduce safety and health risks by technological protection measures, safeguarding workflows, preventive maintenance, suitable protective clothing, training, health-enhancing measures, and controls.
- to refrain from environmental degradation that impairs the basis for the preservation and production of food, denies access to drinking water and sanitary facilities, or causes damage to health, for example through harmful soil change, water or air pollution, noise emission and/or excessive water consumption.
- to not violate the industrial property rights of third parties (patents, trademarks, etc.) as well as to comply with all nationally and internationally applicable intellectual property laws.
- not to participate in or support any form of corruption, of granting undue advantages or bribes.
- not to participate in or support any form of money laundering activities.
- to avoid conflicts of interests.
- to comply with national and international rules of fair competition, in particular applicable antitrust laws and other laws regulating competition.
- to comply with applicable accounting standards and disclose financial information in accordance with applicable national and international regulations.

# 3. Export control and economic sanctions

The Supplier is required,

- to comply with economic sanctions as well as export and import laws with respect to
  - import and export of goods; cross-border transfer of services;

# 4. 数据保护

供应商有义务

- 认真对待个人数据或以其他方式获得的信息 的保护和保密工作。
- 遵守适用的数据保护法,尤其是《欧洲通用 数据保护条例》(GDPR)。
- 以保密的方式收集和处理个人数据,并且仅 在有具体、明确的业务目的的情况下,根据 适用的法律法规收集和处理个人数据.
- 保护所有相关方的个人权利,保护个人数据 免遭滥用和/或未经授权的访问。

# 5. 环境保护

供应商有义务

## 合规和环境授权

- 遵守与环境保护有关的所有国家法律和准则,并引入有效的持续监测程序。
- 获得所有与环境相关的生产和运营授权和注册,并保持更新,同时遵守运营要求和报告要求。

#### 对待自然资源

- 保护自然生态系统,不助长天然林和其他自然生态系统的改变、砍伐或退化。
- 保护或(在可能的情况下)改善生物多样性和土壤质量。
- 最大限度地减少、优化或(在可能的情况下)避免使用自然资源,如水、化石燃料、矿物和原始森林产品。这应涉及各种程序和

# 4. Privacy and data protection

The Supplier is required,

- to take the protection and confidentiality of personal data and other information shared with him very seriously.
- to comply with all applicable privacy laws, especially the European General Data Protection Regulation (GDPR).
- to collect and process personal data in a confidential manner and only to the degree necessary for fulfilling a concrete and definable business purpose and only in compliance with all applicable laws and provisions.
- to preserve the personal rights of all parties involved and to protect personal data from misuse and / or unauthorized access.

# 5. Environmental Management

The Supplier is required,

#### **Compliance and environmental permits**

- to comply with all applicable national laws and regulations regarding environmental management as well as introducing effective processes for monitoring changes and updates.
- to have all valid and required environmental permits, approvals and registrations for production and operations obtained, maintained and kept current. The Supplier will also follow the operational and reporting requirements which are part of the permits.

#### Management of natural resources

- to protect natural ecosystems and not to contribute to the changing, deforestation, or damage of natural woodland and other natural ecosystems.
- to protect or (where applicable) improve biodiversity and soil quality.
- to minimize, optimimize or (where applicable) avoid the use of natural resources, including wa-

## 废物和减少废物

- 考虑所提供产品或服务避免浪费和再利用/ 再循环的可能性和机会。最好考虑整个生命 周期(开发、生产、使用、使用结束和/或 回收)。
- 遵守相关的危险废物出口禁令,特别是 1989 年 3 月 22 日的《控制危险废物越境转移及 其处置的巴塞尔公约》。

#### 水资源管理

- 防止过度用水,促进节约用水和/或重复用水 技术的实施和持续发展。
- 对废水进行定性、监测和控制,并在排放或 处置前进行必要的处理(如适用)。
- 水管理应包括水源(来源)、水利用和水排放的记录、识别和监测。

- ter, fossile fuels, minerals and virgin forest products. Here, approaches and practices such as, for example, modifying production, maintenance and facility processes, materials- substitution, reuse and recycling, can be applied.
- to prevent pollution and environmetal incidents (during every phase of production and/or service delivery).

#### Pro-active approach in environmental management

- to develop initiatives and introduce measures (considering the cost-benefit ratio) reducing the use of energy, raw materials and water (pro-active approach to resource efficiency).
- to develop initiatives and introduce measures (considering the cost-benefit ratio) minimizing the emissions to air, water and soil (pro-active approach to emissions minimization).

#### Waste and waste reduction

(in particular non-hazardous and solid waste)

- to have an efficient operative process in place of characterizing, sorting, reducing, and disposing, forwarding, or recycling (solid) waste in accordance with the applicable regulations and laws.
- to consider, along the life cycle of the supplied products or services delivered (development, production, use, subsequent end-of-use / disposal), opportunities of reducing waste generated and opportunities of recycling and/or reuse.
- comply with relevant prohibitions on the export of hazardous waste, in particular the "Basel Convention on the Control of Transboundary Movements of Hazardous Wastes and their Disposal of March 22, 1989".

#### **Water Management**

- to prevent excessive water consumption and to support the implementation and continued development of technologies for conserving and/or re-using of water.
- to characterize, monitor and control wastewater and, if applicable, to treat as required before discharge or disposal.
- The water management initiatives shall also comprise documenting, characterizing, and monitoring water sources, use and discharge.

# 6. 禁用物质和化学品管理

供应商有义务

- 遵循以下约定中的指导原则:

The Supplier is also requested to strive for initiatives of water management and sustainable use of water in operational planning, i.e. by taking water stress assessments in operations (throughout the life cycle) into consideration.

#### Air emissions and clean air

 to have an efficient operative process in place, conducting periodic characterization and monitoring of air emissions of organic chemicals, aerosols, corrosives, particulates, ozone depleting chemicals and combustion by-products generated from operations. Measures need to be taken to minimize these emissions. The minmium goal is the compliance with national legal requirements.

## Energy management and greenhouse gas emissions

- to monitor and minimize energy consumption and relevant Scope 1 (direct CO<sub>2</sub> emissions) and Scope 2 (indirect CO<sub>2</sub> emissions) CO<sub>2</sub> equivalents to support cost-effective purchasing, implementation and continued development of energy efficient technologies.
- to strive for the conversion to renewable energy sources.
- to strive for climate neutrality in scope 1 and scope 2.

# 6. Prohibited substances and chemical management

The Supplier is required,

- to comply with the requirements laid down in the following conventions:
  - o the Minamata Convention on Mercury,
  - the Stockholm Convention on Persistent Organic Pollutants.
- to comply with the requirements of the "Hengst Environmental Standard" (Hengst Technical Standard, BN 13.09). This document is available for download at <u>www.hengst.com</u>, section "Purchasing":

 In this environmental standard (BN 13.09), substances / substance classes are compiled, which, for the protection of people and the environment, must not be contained in materials or

components, or may only be contained in materials or components if substances which are comparable and uncritical from an environmental and economic point of view, are verifiably not available. The decision to use them is only taken after an assessment of the potential risks with regard to the specific application.

For products and services (service processes performed) which are supplied or provided to Hengst, the Supplier undertakes,

- to identify / characterize substances which require a registration (BN 13.09, section 10), and
- not to utilize / use prohibited substances (BN 13.09, section 10).

#### **Chemical Management**

The Supplier is required to have efficient operative processes in place,

- which identify chemicals and other substances, which are potentially harmful substances if released into the environment. The application of these chemicals and other substances identified, shall be minimized. The application of substitutes (with lower hazard potential) shall be considered
- which serve as a management system for hazardous materials enabling safe handling, transport, storage recycling, reuse, and disposal of such materials.

## 7. Conflict Minerals

#### **Definition**

Conflict minerals are tantalum, tin, gold and tungsten, which are mined from the Democratic Republic of Congo and neighboring areas.

# **Conflict Minerals Reporting (CMRT)**

The Supplier is required,

 to immediately report every application and every discovered application and the evidence of a possible use of conflict minerals in parts, components, materials or products delivered to Hengst (BN 13.09, section 10.11). The reporting to Hengst shall be made by using the most recent CMRT\* template by the Responsible Minerals Initiative.

# 8. 实施

The Supplier is required,

 to comply with the requirements outlined in this Supplier Code of Conduct and to adequately address them along its supply chain, to identify risks and to take adequate measures to eliminate such risks.

We also expect from our Supplier,

 to appropriately address the requirements set out in this Supplier Code of Conduct along its supply chain and to participate in risk analyses and preventive measures by its Suppliers.

We will provide trainings on compliance with and implementation of our expectations from this Supplier Code of Conduct and look forward to a constructive exchange with our Suppliers.

We reserve the right to regularly verify compliance with this Supplier Code of Conduct by requesting the Supplier to carry out a self-assessment of its Supplier sustainability, by conducting Supplier audits and by taking other appropriate control measures and the Supplier is required to cooperate to the best of its ability.

Any (potential) breaches of the requirements set out in this policy can be reported via the reporting channel on our company website

(https://www.hengst.com/de/unternehmen/Compliance), which is available to all employees and third parties. The reporting channel is freely accessible, can be used in various languages and allows anonymous reporting if desired. We have published a guideline that describes the process for submitting and processing reports at Hengst.
